**Question: Should NWTFC rally information be shared with other non-Trek organizations/associations – Safari International, Monaco chapters, etc.**

\_1\_ No, do not share NWTFC rally information with any other organizations – info is available through the website and newsletter only.

Following ratification of this action at the board meeting at the pre-rally, it would be well to consider how to implement this action. I would suggest that pre-rally info not be published since we often have limited space and we are preparing for service at an FMCA convention.

It would seem that the notification would be one of the things that the Rally Coordinator could do, since that person is the one who has the official info on the rallies.

As far as letting Safari and Monaco chapters know of NWTFC info/rallies, perhaps the club newsletter could be sent to these chapters/organizations to inform them.
